Description

The Pulsar 5×30 monocular converts the Krypton XG thermal imaging module into a handheld thermal imaging monocular with 5x magnification.

The monocular can be installed on the thermal imaging module without an additional adapter.

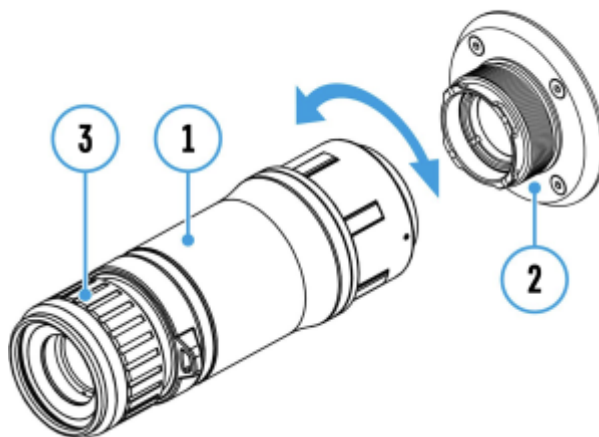

Monocular installation



- 1.** Align the tabs on the monocular **(1)** with the slots of the mounting area **(2)** of the thermal imaging module.
- 2.** Turn the monocular clockwise to secure it on the thermal imaging module.
- 3.** Adjust the monocular's eyepiece diopter ring **(3)** until the symbols in the thermal imaging module's display are sharp.

4. To remove the monocular, turn it counterclockwise and disconnect from the thermal imaging module.

Note: the monocular can be installed on a thermal imaging module with a PSP Ring Adapter. The PSP Ring Adapter must be mounted onto the thermal imaging module until it stops.
